Dr. Eaglen has held a variety of positions in medical education and accreditation during his professional career, including service at various institutions as an associate dean for academic affairs, executive director of faculty and learning services, and scholar in residence. His experience spans a variety of academic areas, including curriculum management and implementation, faculty affairs, and library services. He is also a periodic reviewer for the journal Academic Medicine and has twice received that journal's award for Excellence in Reviewing.



Dr. Eaglen is probably best known in his former role as an associate vice president at the Association of American Medical Colleges (AAMC) in Washington, DC. In that capacity he served as the assistant secretary for the LCME, providing staff support for the organization that included a major revision of accreditation standards in 2002 and participation on accreditation surveys for medical schools across the United States and Canada. As an LCME field secretary he continues to serve as the secretary on LCME accreditation survey teams, and he has also participated in accreditation surveys of law schools.

Dr. Eaglen received his Ph.D. degree in biological anthropology from Duke University in 1980.

John Mahoney, MD Emergency Medicine Former Senior Associate Dean for Medical Education University of Pittsburgh

With over 25 years at the University of Pittsburgh School of Medicine, John F. Mahoney, MD is Associate Dean for Medical Student Education and an adjunct professor in emergency medicine. He also practices as an attending physician in the emergency department and Vice President of Medical Education for ScholarRx, which helps medical students prepare for the boards



using digital learning on a multi-competency curricular platform. Dr. Mahoney is a noted expert in medical

education and curriculum development and helped design Pittsburgh's integrated clerkships. He also led changes in medical education methodology and content that significantly influenced the entire curriculum at the Pittsburgh SOM. Earning his MD at the University of Pittsburgh School of Medicine, Dr. Mahoney completed an internship at Mercy Hospital of Pittsburgh and his residency in emergency medicine at George Washington and George Washington and Georgetown University Hospitals.

Lois Margaret Nora, M.D, J.D, M.B.A. Neurology Professor of Neurology President Emeritus and Dean of Medicine Emeritus Northeast Ohio Medical University

Dr. Lois Margaret Nora is Professor of Neurology, President Emeritus, and Dean of Medicine Emeritus at Northeast Ohio Medical University. She also serves as Principal of the Medical School Advisory Group. From 2012-2018, Dr. Nora served as President and Chief Executive Officer of the American Board



of Medical Specialties (ABMS), and during her tenure, the organization initiated the "Continuing Board Certification: Vision for the Future" initiative. During 2018, Dr. Nora was a Fellow in the Advanced Leadership Initiative at Harvard University, where her work focused on accreditation as a lever for positive change in education. She also continued work on the history of women in medicine. Dr. Nora currently serves on the Steering Committee of the National Academy of Medicine's Action Collaborative on Clinician Well-being and Resilience and the Board of Visitors of the University of Mississispipi School of Pharmacy. She has served as the President of the American Association of Neuromuscular and Electrodiagnostic Medicine, Chair of HRSA's Council on Graduate Medical Education (COGME), on the Board of Directors of the Association of American Medical Colleges, and as a trustee of the Margaret Clark Morgan Foundation. Dr. Nora received her medical degree from Rush Medical College, a law degree and certificate in clinical medical ethics from the University of Chicago, and a Master of Business Administration degree from the University of Kentucky.
