
Message From the Chair

Welcome to our department quarterly newsletter.

We have a huge backlog of exciting news about our faculty, staff and learners, but space only for items going back about six months.

I am devoting this column to our department's finances for the year ending June 30, 2021. Although I went into some depth during our September Faculty Meeting, I want to ensure all faculty have access to this information.

First, let me start with a definition of contribution margin (CM), the bottom-line metric that the College uses to access our financial performance (see figure). Academic departments contribute surplus/deficit, dean's tax (10% clinical revenue). and indirect grant/contract recoveries. Embedded in each department's surplus/deficit are its direct revenues (i.e., medical service revenues, direct recoveries, affiliate payments, endowments, etc.) and certain direct expenses (e.g., salaries, rent, services, supplies, travel, etc.).



Of no surprise to anyone, COVID-19 affected both FY20 and FY21 financial data. However, as some restrictions on clinical activity were lifted and we pivoted to telepsychiatry, we can see evidence of recovery in our CM.

We ended the year with a **\$1M positive variance** largely due to the surplus in actual revenues minus budgeted expenses that equaled over \$1.4M. Despite the operational limitations experienced during the COVID-19

pandemic, the department continued to lead the telemedicine transition initiative and remained otherwise successful in clinical and research missions that resulted in \$1.8M FY21 CM. While this sizeable CM is something to be proud of, please be aware that all these funds are returned to the College and are not available for the department to spend.

The financial outlook for the department is productive, yet challenging for Fiscal Year 22 and beyond. In addition, in response to both COVID-19 and reductions of funding, the department is embracing the telehealth model of care and allowing some options for faculty/ staff telecommuting to reduce the operating cost and physical footprint of the department. The department has taken steps to consolidate

Dr. Shah Honored by the Pakistan Psychiatric Society

Dr. Asim Shah, professor of psychiatry & behavioral sciences and chief of psychiatry at Ben Taub Hospital, was honored by the Pakistan Psychiatric Society as Eminent Pakistani Psychiatrist 2020. The society cited his "25 years of meritorious achievements in teaching and training, remarkable expertise in community and disaster psychiatry and outstanding services in public and media engagement for promotion of mental health globally."

Psychology Internship Program Accreditation

Dr. Phuong Nguyen, Director of the Psychology Internship Program, is pleased to share the American Psychological Association Commission on Accreditation (CoA) voted to reaffirm accreditation of the program for the maximum period allowed (10 years).

This decision is based on the CoA's professional judgment that the program has demonstrated it adheres to the Standards of Accreditation in Health Service Psychology. The program will be listed among accredited programs in health service psychology on the accreditation web pages. The Commission recognized the exceptional quality of training provided by the program and deemed it in substantial compliance with the Standards of Accreditation. The program's next site visit is scheduled for 2030.

We would like to thank everyone involved in the accreditation process, including the completion of the self-study, as well as, the site visit held in February. Special thanks to the department leadership, members of the internship training committee, and especially the psychology interns from current and past years for their support.

DISPARITIES GRANT

Technological Determinants of Health Factors associated with equitable utilization among minority adolescents and young adults receiving sexual health services

A multidisciplinary collaborative team including adolescent medicine (MPI Megna Sebastian, MD), public health (MPI Allyssa Abacan, MPH, Peggy Smith, PhD), psychology/psychiatry (Eric Storch, PhD, pictured) and pediatrics (Miriam Chacko, MD) was awarded a \$50,000 Health Disparities grant from BCM to explore telehealth acceptability and digital inequities (device access, internet access, and digital literacy) affecting utilization of telehealth for sexual health services among adolescents and young adults. Mixed methods will be used to 1) survey attitudes, barriers, and acceptability of telehealth services for STIs, and 2) understand through qualitative interviews attitudes, barriers, and facilitators around technology.



APPOINTMENT

Dr. Saunders: New DEI Position

The Menninger Department of Psychiatry and Behavioral Sciences is pleased to appoint Dr. John Saunders as its inaugural Vice Chair for Diversity, Equity, and Inclusion (DEI) effective September 1, 2021.

Dr. Saunders also has been selected as a Fellow in the Equity Matters DEI Leadership Learning Community by Accreditation Council for Graduate Medical Education. He will complete an 18-month program and present a capstone project.

Dr. Saunders was born in Oklahoma, raised in Texas, and completed his undergraduate education at the University of Oklahoma in 2004 with a Summa Cum Laude B.S. in Microbiology and a Summa Cum Laude B.A. in Psychology. He received his M.D. at University of Pittsburgh School of Medicine and completed his Psychiatry Residency and Community Psychiatry Fellowship.

In 2015, he joined BCM as a faculty member in the Menninger Department of Psychiatry and Behavioral Sciences, where he has been working at Harris Health. Among his many honors and awards, Dr. Saunders is a recipient of a Norton Rose Fulbright Teaching and Evaluation Award and was selected as a Health Scholar for the BCM Center of Excellence in Health Equity Program.

In this new position, Dr. Saunders will have the opportunity to expand and coordinate elements of Diversity, Equity, and Inclusion that have already been developed as well as create new initiatives in alignment with BCM's offices of Institutional Diversity and Inclusion. Working closely with our Affiliates, he will assist with the development, implementation and tracking of outcomes for the Department's DEI Action Plan. He will leverage his existing clinical role at Harris Health to foster community engagement on issues of mental health inequities. As Vice Chair for DEI, Dr. Saunders will also chair the Department's DEI Committee, which includes its Faculty Inclusion Ambassadors.




EDUCATION PROGRAM UPDATES



Dr. Lynnette A. Averill, Associate Professor of Psychiatry (Neuropsychiatry Division) gave an invited presentation for a private donor "Parlor Event" for the Brain and Behavior Foundation (BBRF) in May. Her presentation titled, "Of Forests, Trees, and Mushrooms: New Knowledge and Treatment Possibilities for PTSD and Suicidal Thoughts and Behaviors," provided a review of the evidence and discussion of ketamine and psychedelic medicine approaches. An adapted transcript of this presentation will be included in the upcoming issue of the BBRF's magazine, *Brain & Behavior*.

Dr. Averill joined the BCM faculty in December 2020. Her line of research will provide a strong understanding of the relationship between synaptic dysconnectivity, chronic stress pathology, and treatment response while rapidly improving often treatment-resistant symptoms in patients.

Division of Global Mental Health Updates

The BCM Division of Global Mental Health, comprising the Clinic for International Trauma Survivors (CITS) and the Anti-Human Trafficking Program (AHTP), remains involved in teaching and educational trainings, clinical care, research, and advocacy.

The Global Mental Health elective increased from 2-4 weeks, while 3rd year residents and child psych fellows rotate at the CITS. The AHTP Post-Doctoral Fellow Dr. Nicole White began in summer 2021. Practitioners see patients at the CITS, The Alliance Wellness Clinic, and the Anti-Human Trafficking Program.

Group Therapy for Congolese Men at The Alliance and a Trauma Therapy Group at Ben Taub will be starting this fall. Faculty continue to train healthcare providers on human trafficking for licensing requirements under an OVC grant. The Division looks forward

to a Physicians for Human Rights training
November 13, organized by Human Rights and
Asylum Clinic. Additionally, faculty and trainees
lecture at empowerment groups, HIAS, grand
rounds, national meetings, and teaching
hospitals across the United States. IRBapproved research continues with over a half
dozen newly published peer-reviewed articles
and book chapters this year. Task Forces were
established on mental health for Afghani
Evacuees and Congolese clients. Community
engagement includes food and hygiene drives
and outreach panels.

International Advocacy at the UN resulted in the publication of the Delta Justice Policy Guide, and team members continue to train international governments in building capacity for gender-based violence.
