ACCREDITATION SITE VISIT UPDATES

COA Site Visit Oct. 16th to Oct. 17th

The Baylor College of Medicine Doctor of Nursing Practice Program – Nurse Anesthesia is accredited by the Council on Accreditation of Nurse Anesthesia Educational Programs. The program was last reviewed in 2013 and received the maximum 10 years continued accreditation. The program is currently undergoing review for continued accreditation in accordance with the 10 year accreditation cycle. Dr. Rachel Davis, Associate Professor and Director of the DNP Program is leading the team of DNP Program Faculty and Staff to complete the self-study and prepare for the onsite visit.

The team consists of: Dr. Megan Bullerwell, Associate Director; Dr. Aimee Langley, Associate Director; Dr. Jessica Gaines, Mr. Nate Jones, Dr. Jim Walker, Ms. Emily Hughes, and Ms. Ramona Miller. The Office of Accreditation, and SHP Dean, Dr. Todd Reinhart have also been invaluable throughout this process.

The self-study was submitted to the COA on August 7. We will welcome the onsite review team for a visit October 16-17.

While here, the review team will meet with College leadership, DNP Program faculty and staff, Clinical Faculty, including CRNAs and Anesthesiologists, and the entire student body. They will observe Student Registered Nurse Anesthetists in the clinical setting, and tour the facilities in which our students learn and train.



Temple SACSCOC Substantive Change Site Visit Jan. 29th to Feb. 1st

The School of Medicine welcomed its inaugural class of medical students to the Temple regional campus this summer. Forty students make up the group of first year students. Ninety-two percent of the Temple students are from Texas. As part of this process of "One School, Two Campuses" Baylor College of Medicine will host the SACSCOC (Southern Associate of Colleges and Schools Commission on Colleges) accreditation body next year in Temple, TX.

The substantive change committee visit ensures the site has the personnel, facilities, and resources identified by an institution in its application or prospectus and ensures the quality of instructional and support services offered at the site.

LCME ELEMENT 8.1 -CURRICULAR MANAGEMENT

"A medical school has in place a faculty committee that has responsibility for the overall design, management, integration, evaluation, and enhancement of a coherent and coordinated medical curriculum."

Element 8.1 focuses on a particular organizational body that is responsible for the curriculum. This committee is a system of organized people working together to get things done efficiently and to detect and respond to short-term concerns/needs and long-term challenges/needs efficiently and effectively to making sure that the curriculum is working.

The School of Medicine's Curriculum Committee is the faculty committee with primary responsibility for the oversight and management of the undergraduate medical education curriculum. The source of the Curriculum Committee's authority is specified in the Faculty Bylaws of Baylor College of Medicine (BCM login required). The Curriculum Committee's authority is further specified, as a connection from the faculty by laws to BCM's Establishment and Operation of Institutional and School Committees policy (BCM login required). In addition, the policy includes the charge of the Curriculum Committee.

The Curriculum Committee has the responsibility and authority to make necessary changes in the curriculum to meet Liaison Committee on Medical Education (LCME) standards and to ensure that the students fulfill the Core Competency Graduation Goals (CCGGs). The Curriculum Committee is also responsible for updating the Sr. Dean of the Schools of Medicine and Health Professions on its actions.

Although the Curriculum Committee has the responsibility and authority to make necessary changes in the curriculum, to facilitate ongoing review, the curriculum committee charges the Subcommittees to focus on specific aspects of the curriculum.



The subcommittees make recommendations for changes in content and direction of the course or clinical rotation by utilizing data analysis and reporting support from the Curriculum Office, directors of each course, clerkship, elective and sub-internship to the Curriculum Committee for discussion and approval.

The Curriculum Committee receives recommendations from the subcommittees, and through review and discussion of the recommendations, it may approve, modify, table, or reject the recommendations. Minutes of the Curriculum Committee meetings include the reports and recommendations of the subcommittees; summaries of deliberations, actions taken, and recommendations made by the Curriculum Committee.

The composition of the Curriculum Committee, how its members are selected, the number and categories of its members, and member terms of service are described in the <u>Curriculum Committee Procedures</u>.

INSTITUTIONAL RESEARCH

Institutional Research (IR) is excited to share some important information regarding the <u>Integrated</u> <u>Postsecondary Education Data System (IPEDS)</u> reporting for the upcoming 2023-24 academic year (<u>reporting</u> <u>calendar</u>):

Why is IPEDS reporting important?

Accurate and timely reporting through IPEDS is vital for Baylor as it influences institutional rankings, federal funding allocations, and various research initiatives. The data collected helps policymakers, researchers, and the public make informed decisions about higher education.

Our Commitment to Data Accuracy

At Baylor, we are dedicated to upholding the highest standards of data accuracy and integrity. IR, in close collaboration with the Office of the Registrar, Office of Student Financial Aid, Finance, Human Resources, and Library departments, has been diligently preparing for the IPEDS reporting to ensure the submission of accurate and timely data.

Useful IPEDS Resources

- <u>College Navigator</u>: Users can 1) search colleges based on location, programs, degree offerings, and other characteristics. 2) obtain information on admissions, student expenses, financial aid awarded, retention and graduation rates, enrollment, completions, accreditation status, and more. 3) designate favorite institutions by comparing up to four institutions side-by-side.
- <u>College Affordability and Transparency Center</u>: The site highlights institutions with the highest and lowest tuition and fees and the highest and lowest net prices. Net price is the cost of attendance minus grant and scholarship aid. The site also houses College Scorecard, which summarizes information from IPEDS and other data sources to help students and families make more informed decisions about which college to attend.
- <u>IPEDS Databases</u>: The IPEDS database allows the public to retrieve current and historical IPEDS data. The data is used by institutions, researchers, education providers, professional associations, private businesses, the media, and many others.
- <u>Data Feedback Reports</u>: This annual report, published each fall, may be useful to institutional leaders for benchmarking and peer comparison. Here is the <u>DFR 2022 Report for BCM</u>.

A fundamental principle for learning improvement, the "Weigh Pig, Feed Pig, Weigh Pig" model, is the idea that growth does not happen by way of simply providing measurements; we must feed the pig.

- Creating or modifying assessment plans, providing guidance on appropriate design of outcomes, methods, and criteria.
- Assisting in selection, design, or validity/reliability of assessment instruments.
- Supporting analysis of assessment and program review data.
- Providing workshops and presentations on assessment-related topics.
- Creating crosswalk documentation to include discipline-specific accreditation requirements.
- Conducting survey support and management.
