Identifying and Addressing Moral Distress and Burnout

Objectives: At the conclusion of the session, the participants should be able to:

- Demonstrate an awareness of clinical situations that often create moral distress.
- Describe the process for distinguishing moral distress from other types of distress.
- Identify and apply strategies for addressing moral distress among all members of the healthcare team.
